

Directions For Contributions To The Journal Of Aquatic Plant Management

(Formerly The Hyacinth Control Journal)

Contributions dealing with all aspects of aquatic vegetation management including field operations, research, regulation, and reviews are accepted for consideration for publication in the Journal of Aquatic Plant Management. Authors are encouraged to join the Aquatic Plant Management Society, but membership is not a prerequisite for acceptance of a manuscript. Manuscripts will be accepted at any time during the year for review; however, the Journal is published once a year with an approximate publication date of May of each year. Most manuscripts are received at the annual meeting in July of each year.

Each manuscript is accepted for review on the basis that it has not been published elsewhere except in abstract form. Publication of the information as an abstract should be footnoted in the Introduction section. Reviewers are selected by the Editor and Associate Editors.

I. *Title*—The title should be as short as practical, preferably 50 characters or less in length, and centered at the top of the page followed by the author's(s) name with their respective titles and addresses including zip code. For example:

II. *Format of Text*—The format for headings and sub-headings will depend upon the type of information to be presented. Generally, a research oriented manuscript should begin with an Abstract, followed by an Introduction, Methods and Materials, Results and Discussion, Acknowledgements, and Literature Cited sections in that order. If an Abstract section is not included, then a Summary section should be placed after the Results and Discussion. Manuscripts containing information of a general nature or reviews should have headings and subheadings which adequately describe the information presented.

III. *Literature Cited*—Use the numbering system for referring to references cited in the text. Reference to information that would not be readily available in a library should be footnoted, and not included in the Literature Cited section. References in the Literature Cited section should be listed in alphabetical order. For example:

1. Phillippy, C. L. 1962. The effects of aquatic vegetation on fish. *Hyacinth Contr. J.* 1:7-8.

IV. *Tables*—Each table should be placed on a separate page. The tables should be numbered in Arabic numerals in order of reference in the text and then placed in the manuscript after the Literature Cited section.

V. *Figures*—Original India ink line drawings or glossy prints (preferably 8 x 10 inches in size) should be submitted. Do not send photocopied material for figures as these

will result in very poor reproductions when placed in the Journal. Lettering should be with a lettering guide or with other similar instruments; freehand or typing is not acceptable. The author's name and figure number should be written in pencil on the back of each figure. The legend for each figure should be typed on a separate page entitled List of Figures.

VI. *Use of Arabic Numerals in the Text*—Use a numeral whenever a number is followed by a standard unit of measure such as acre, mile, gram, hour, or its abbreviation; otherwise spell out numbers through nine and then use a numeral for larger numbers. In a series containing some numbers under 10 and other over, use numerals for all. If at all possible, avoid beginning a sentence with a numeral.

VII. *Plant Names*—When first mentioned in the text, give the common names followed in parentheses by the complete scientific name. Then use the common name throughout the text. In cases where many plants are referred to in the text, place the common and scientific names in a table, and use only the common names in the text.

VIII. *Chemical Names*—At the first mention of a chemical in the text give the complete chemical name followed in parentheses by the common or trade name. Capitalize trade names. Use the common or trade name throughout the text. Place lists of chemicals in a table. Base all concentrations on the active ingredient or state the formulation that was used.

IX. *Typing*—All typewritten material including tables is to be double-spaced on standard size paper (8½ x 11 inches). Allow a 1½ inch margin around each page. Manuscript guide or paper with numbered lines is preferred. Manuscript guide paper may be obtained from the Secretary or Editor of the Society.

X. *Number of Copies*—Two copies of a manuscript should be submitted to the Journal, one the original, and the second a carbon or photocopy. The authors(s) should retain an additional copy to insure against loss. Send manuscripts to: Aquatic Plant Management Society, P.O. Box 2237, Fort Myers, Florida 33902, or David L. XI. *Units of Measure*—The metric system is preferred by the Journal of Aquatic Plant Management; however, standard U.S. measure is acceptable in cases where it increases the understanding of a manuscript. Do not mix metric and standard U.S. measurements in the same manuscript; use one or the other, but not both. In some instances one unit of measure may be converted to the other and then placed in parentheses following that measure. For example: 1.0 lb (453.6 g).

XII. *Abbreviations*—Those published in The Third Edition of the Style Manual for Biological Journals.
